2. Treasurer's Report

- 2.1 Takings at the September and October film nights were £850 and £785
- 2.2 Oktoberfest takings were £1,183
- 2.3 All available tables at the Christmas Fayre have been booked and paid for
- 2.4 Hall insurance has been renewed at a cost of £1,233.49
- 2.5 Rustington Glazing's invoice (2 replacement front windows) of £898.80 had been paid

3. Correspondence

- 3.1 Small Claims Court proceedings are to be instigated by the Treasurer against a hirer who has failed to pay additional charges relating to the replacement of a drain cover damaged by their caterer, following reminders issued
- 3.2 A discount has been applied to the hire charge incurred by Strictly Dancing after a mix up over a booking date. The Hirer's request for the charge to be waived completed was respectfully declined
- 3.3 Biffa failed to empty the skip on two consecutive weeks and a credit will be issued

4. Bookings Report

- 4.1 Tai Chi now has two sessions on a Friday
- 4.2 A new weekly Yoga Group starts up on 29th November
- 4.3 Enquiries in hand for a Fitness Group and Committee Room

4. Chairperson's Report, including Events

- 4.1 Refurbishment of the roof is complete and Pat Doyle has a stock of replacement KeYmer tiles in the event of any
- 4.2 A code box will be fitted to the barrier and it will come into use as and when deemed necessary in the New Year
- 4.3 One room over the toilets has been emptied of contents and painted so it can be utilised as archive storage for the Trust. The smaller room housing the CCTV and stairs will be painted in due course. A new door is to be fitted and keys issued to Chairperson, Secretary and Treasurer only
